



DISCLOSURE OF INVESTMENT INTEREST

As passed by the Georgia General Assembly, the “Patient Self-Referral Act of 1993” (O.C.G.A. § 43-1b-1, et seq.), as amended, requires that healthcare providers* must notify patient in writing of any investment interest that the provider has in certain healthcare facilities or services to which he or she may refer you to. The Georgia General Assembly recognizes that such referrals may represent a potential conflict of interest.
